Discussion includes goals in treating osteoarthritis patients, a review of the process of osteoarthritis, maladaptive pain and its relationship to the arthritic pet, pharmaceutical and nutraceutical OA interventions, physical interventions for OA, and photobiomodulation and pain management for OA via laser therapy.
